- 5. Applicants are advised to ensure before applying that they possess essential qualification and experience for the post. - 10. The character of a person for direct recruitment to the service must be such as to render him/her suitable in all respect for appointment to the service. - 13. EWS vacancies are tentative and subject to further directives of Government of India and outcome of any litigation. The appointment is provisional and subject to the Income and Asset certificate being verified through proper channel and if the verification reveals that the claim to belong to EWS is fake/false, the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provision of the Indian Penal Code for production of fake/false certificate.
- 14. The persons with Degree of Disability of 40% and above are eligible for applying for the PwBD.
