# Empanelment of Specialist on case to case basis in ESIC Hospital, Bareilly for a period of one year through walk-in-Interview.

ESI Corporation is a statuary body constituted under the ESI Act, 1948 under Ministry of Labour & Employment, Government of India. ESIC Hospital Bareilly is a 50 bedded hospital and committed to provide cashless secondary care/ super specialty services to the ESI beneficiaries. In order to meet the shortage and to provide in house services to the ESI beneficiaries, ESIC proposes to empanel Specialists for "on demand professional services" for a period of one year through Walk in Interview after evaluating the rates quoted by the applicants.

Interested candidates can submit their capitation fee (% of CGHS rate) along with academic documents in a sealed envelope on or before 05.04.2021 at ESIC Hospital, Sleeper Road, C B Ganj, and Bareilly.

#### 1. Empanelment of Specialist.

The doctors will be empanelled on the basis of the eligibility criteria, capitation fees as mentioned above.

A list of empanelled doctors as L1, L2 and L3 (as per requirement) shall be prepared based on % of CGHS package/ Procedure rate in the increasing order.

### 2. Terms and Conditions

The appointing Authority reserves the right to cancel the offer/ advertisement without assigning any reason thereof.

The empanelled doctor shall sign the acceptance of the offer letter.

Age Limit should not be more than 70 years on the date of interview.

#### 3. Duties and Responsibilities of empanelled doctor.

The empanelled doctor, whenever called for, will provide the professional services to the ESIC beneficiaries at ESIC hospital as per terms and conditions based on offer of professional fees linked to CGHS package/procedures.

The empanelled doctor shall also provide post procedure care with minimum of two visits per day (one in morning and another in evening), till the patient is discharged.

The empanelled doctor will be available round the clock for professional services.

The doctor is required to complete the paper work/ case sheet as required by the ESIC Hospitals.

The doctor may also advise/ recommend to refer the entitled beneficiaries to tie up/ higher centre if the condition of the patient so requires.

The doctor has to ensure that the record of all his indoor patients are updated, medicines and services are delivered to the patient.

The doctor will be responsible for any deficiency/negligence in the delivery of professional services.

#### 4. Responsibilities of ESIC.

L1 empanelled doctor from the list shall be called for the professional services. However, if the first L1 doctor on empanelment is not available then the next empanelled doctor on the panel may be called up based on the urgency of procedure.

If the empanelled doctor does not provide the post operative case after the procedure, Medical Superintendent may call next empanelled doctor for the same and proportionate deduction shall be made from the list of first empanelled doctor who had performed the procedure.

To provide the infrastructure to the empanelled doctor to perform professional services.

To provide required manpower to assist empanelled doctor during the delivery of professional services.

To provide drugs, dressings, consumables etc for professional procedure.

To shift the patient to higher centre in case of emergency or exigency and when the situation arises in order to save the life of the patient.

## 5. Agreement and Applicability of Laws.

The both parties shall have the full power and authority to enter into this agreement and to perform the acts required of it.

The party shall comply with all applicable Laws, Statues, Ordinances, Orders, Rules and Regulations in operation in the country.

## 6. Termination of empanelment

it is expected that the doctors will observe the highest standard of ethics during the execution of the empanelment

#### The following may result in termination of empanelment:-

- Any collusion with the doctor/staff.
- Malpractice.
- Misrepresentation.

- After joining the regular specialist.
- Medical negligence in providing/ delivering his medical services.
- Any other as decided by Medical Superintendent.
- The appointing authority may terminate the agreement of the empanelment Specialist with or without assigning any reason whatsoever after giving a notice of 30 (Thirty) days to the doctor.

## 7. Period of Empanelment.

Such empanelment is valid for one year from the date of signing of contract.

It is extendable for one year with mutual consent of both the parties.

## 8. Documents Required.

Date of birth Certificate.

Certificates of Educational Qualifications, professional qualification, registration of Medical Council and experience.
