(3) All qualifications and experience will be considered as on the closing date, i.e. the last date of submission of application form. (4) Candidates are called for the Seminar-cum-Presentation and Interview on the recommendations of the screening committee of the Institute and as such all applicants may not be called for Interview. (5) Schedule of the Seminar-cum-presentation & Interview and the list of the Shortlisted Candidates will be displayed on the Institute website. (6) The Institute also reserves the right to fill the posts on temporary basis or not to fill any of the post without giving any reason whatsoever. The Institute may also appoint on Contractual basis. The number of posts may vary depending on exigencies. (7) The Institute reserves the right to alter/modify any condition at any stage. (8) Applicants who are in employment should route their application through proper channel or should submit a **"No Objection Certificate"** from the employer prior to the Interview, failing which their candidature may not be considered.
