• Reservation of Person with Benchmark Disability (PWD) will be as per prevailing guidelines of Government of India. In case candidates in these categories are not available, then the vacancies will be filled from the panel of candidates who attend the walk-in-interview in view of essential services of the Medical College and for fulfillment of NMC Norms.

NOTE:

- 1. In case of Non-availability of candidates for faculty positions in a particular reserved category, theavailable meritorious candidate may be given offer of engagement for a period of 44 days at the solediscretionofthe Appointing Authority.
- **2.** Number of vacancies are provisional and may increase or decrease depending on actual number of Vacancies without any intimation.
- **3.** ESIC reserves right to cancel the recruitment process at any stage at its discretion and such decision will be binding on all concerned.
- 4. Candidates intending to apply for multiple cadres may submit separate applications including fee.
- **5**. Candidates applying in **OBC/SC/ST/EWS/PWD** Category must possess the certificate issuedby competent authority, valid for job in Central Govt. Institutions issued before thedate of interview, failing which he/she shall not be allowed to appear in interview for thereservedcategory. However, he/she can betreated as UR Candidate.
- **6.** Candidates claiming reservation on grounds of OBC should submit the community certificate in updated original, as prescribed vide Govt. of India, Dept. of personnel and training O.M No 36036/2/2013 Estt. (Res.) dated 30.05.2014 failing which benefits of reservation will not be given and their application shall be rejected. - d) No Private Practice is allowed during the tenure of service in ESIC.
- e) Retirees from Central/State Govt./PSU from the equivalent posts are eligible to apply.Personsworkingin recognized/approvedprivateMedicalInstitutions fulfillingeligibility criteria for the post may also apply.

8. TERMS OF CONTRACT:

- a) Selected candidates shall be appointed purely on contractual basis for a period of one year, which may be extended for another one/two years onsatisfactory performance subjected to approval of the Competent Authority. The contract would be terminated in case regular incumbent joins.
- b) The contractual engagement can be terminated/discontinued on either side after giving one-month notice.
- c) Barringseriousmisconduct/irregularity,continuationoftheincumbentwouldbebasedonsatisfactoryannual appraisal and approval of theCompetent Authority. Other terms and condition will be applicable as issued by competent authority from time to time.
- d) This being One-year contract, absence for period beyond 15 days without prior permission/approval of Competent Authority will be treated as abandonment of duty and the contract will be terminated without any notice and security deposit will be forfeited.

- k) The doctors at any time found guilty of any gross misconduct or negligence of his/her duties shall be terminated without any notice or payment in lieu of notice period.

11. SELECTION PROCEDURE:

- a) Selection will be made on basis of interview of candidates which will be conducted by the duly constituted selection board.
- b) The applications of the candidates submitted on the day of walk in interview along with therequisite fee will be scrutinized by the scrutiny committee of the Institute and only the eligibleCandidates will be allowed to appear for walk in interview before the selection committee. Incase, the numbers of applicants are large, the selection committee of the Institute may devisecriteria for short-listing of the candidates which

- c) 50% of the total marks would be considered as the criteria for eligibility for selection.
- d) Selected candidates will have to report this office for Medical Examination and Verification of original certificates immediately after receiving Provisional offer of Appointment through email.
- e) The final selection will be based on performance in the personal interview.
- f) Offer of appointment will be provisional subject to verification of original certificates at the time of joining.
- g) Waiting list will be prepared and will be valid for a period of 2months from the date of release of result subject to the approval of the Competent Authority.

GeneralInstructions:

12. CRITERIA OF INCOME & ASSETS (For Economically Weaker Section or EWS)

Persons who are not covered under the scheme of reservation for SCs, STs and OBCs and whose family has gross annual income below Rs.8.00 Lakh (Rupees Eight Lakh only) are to be identified as EWSs for the benefit of reservation. Income shall also include income from all sources i.e. salary, agriculture, business, profession, etc. for the financial year prior to the year of application.

Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income: -

- I. 5 acres of agricultural land and above;
- II. Residential flat of 1000 sq. ft. and above;
- III. Residential plot of 100 sq. yards and above in notified municipalities;
- IV. Residential plot of 200 sq. yards and above in areas other than the notified municipalities.

The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.

The term "Family" for this purpose will include the person who seeks benefit or reservation, his/her parents

and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years.

13. <u>INCOME AND ASSET CERTIFICATE ISSUING AUTHORITY AND VERIFICATION OF CERTIFICATE:</u>

The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority. The Income and Asset Certificate issued by any one of the following authorities in prescribed format as given in **Annexure-** Ishall only be accepted as proof of candidates claim as belonging to EWS:

- ii. Chief Presidency Magistrate/Additional Chief Presidency Magistrate/Presidency Magistrate.
- iii. Revenue Officer not below the rank of Tehsildar and
- iv. Sub-Divisional Officer or the area the candidate and/or his family normally resides.
