**Contractual Engagement of GDMO under XV-Finance Commission-2022-23**

In reference to the letter of Mission Director, NHM & Executive Director, WBSH&FWS vide memo no. HFW-35099/249/2022-NHM- SEC-Dept. of H&FW/539(2) dated 22/09/2022, DH&FWS and Office of the CMOH, Purba Bardhaman is inviting online applications for engagement (on contractual basis) of the following rest posts under Fifteenth Finance Commission (XV-FC) for the FY 2022-23.

The above HR positions have been sanctioned under XV-FC Health Grant based on the following conditions:

- i) Remuneration of the HR will be fixed as per rate of National Health Mission (NHM) as mentioned against the posts. No enhancement will be permitted during the entire tenure up to 2026
- ii) Engagement will be on contract, which will be initially for a period of one year. Maximum period of engagement till 2026 unless and until the project/scheme is further extended.
- iii) Under no circumstances, these HR will be absorbed in regular establishment of the Government.

An application fee of Rs. 100/- (Rs.50/- for reserved categories) will be deposited to the Bank through NEFT in favor of DISTRICT HEALTH AND FAMILY WELFARE SAMITY (NON-NHM) Bank A/C No-0187132000008, IFSC- CNRB0000187. Bank deposit copy (with UTR no.) will have to be submitted with printed copy of the on-line application form, during checking and verification.




General Information for the Applicants/Candidates:

- i) The applicant must be a permanent resident of West Bengal.
- ii) The applicant must have knowledge of local languages (should be able to read, write and speak in Bengali).
- iii) Age relaxation will be given for the reserved candidates as per existing norms of the State Government.
- iv) Only online Applications will be accepted. Application forms not properly filled in or incomplete Application forms are liable to be cancelled. If the online application details submitted by the applicant differ with the original testimonials, that application shall be liable to be cancelled.
- v) If proper signature and photograph are not uploaded at the time of online application that application shall also be liable to be cancelled.
- vi) Hard copy/print copy of the online registration form may be downloaded from the link "https://hr.wbhealth.gov.in/Index.aspx"-> "Application Print" and should be retained by all the applicants for document verification purpose. Without registration form, candidates will not be entertained for original testimonials verification by the authority. No need to send Hard copy/print copy of the online registration form by post.
- vii) The Essential Criteria mentioned are the minimum and mere possession of the same does not entitle the candidate to claim selection. All the essential academic qualification must be completed on or before the last date of online application.
- viii) Selection will be made on the basis of marks obtained in academic qualification & experience.
- ix) All marks must be calculated excluding marks of Additional Subject. No rounding off of marks will be granted. Proportionate marking up to 2 decimal points will be considered.
- x) Experience (if applicable) will be calculated after obtaining the required essential academic qualification for the above-mentioned position, till the last date of online application with supporting documents of Experience Certificate.
- xi) In case of experience from Private Org., the selection committee may ask for salary statement/ appointment letter or any other documents from the agency for the said period for verification.
- xii) The above-mentioned posts are purely contractual in nature with initial period up to March'2025 and it may be renewed for further period depending on satisfactory performance and subject to continuation of the Fifteenth Finance Commission.
- xiii) The decision of the competent authorities regarding the recruitment is final.
- xiv) The competent authorities may cancel the recruitment process at any stage of the selection process.

On the basis of on-line application data, a provisional list will be prepared for original testimonial verification. Print copy of online application form, NEFT documents/screen shot of payment (for online payment) and other supporting documents in favour of age proof, caste, educational qualification etc. will be verified.
