1.	Name of the Post	:	<b>Consultant in PP&amp;R Division of Ministry of External Affairs Headquarters, New Delhi</b>
2.	Period of Consultancy	:	Initially for <b>01 (one) year</b> .  The contract can be extended further depending on assessment of performance, mutual willingness and depending on the requirement. The contract may be terminated on one month's notice from either side or on payment of one month's pay in lieu thereof. Unauthorized absence may lead to termination of the engagement.
3.	Nature of Duties	:	<ul style="list-style-type: none"><li>• The selected consultant will be required to work as domain expert on International Relations &amp; Policy in the PP&amp;R Division of the Ministry.</li><li>• Their duties will entail preparation of briefs, reports, analysis of historical trends and latest developments in geopolitics, geo-economics and geo-strategy.</li><li>• Their duties will entail generation of content on Foreign Policy related issued and provide knowledge-based inputs for the same.</li><li>• They will be required to summarize and analyse published material in the areas assigned to them, as it appears in media or academic journals.</li><li>• They will also be required to attend important seminars and conferences relevant to the work of the PP&amp;R Division and submit reports on them.</li><li>• From time to time, they may also be asked to undertake research on specific foreign policy related issued and draft documents.</li><li>• They would be required to prepare speeches, statements, and presentations on given foreign policy related issues.</li></ul>

Qualifications/Essential Criteria	:	<ul style="list-style-type: none"> <li>• The Applicant should be an Indian national.</li> <li>• Graduate from a recognized university in India or abroad.</li> <li>• Extra credit will be given for specialized domain knowledge/evidence of original thinking/evidence of content writing-peer-reviewed publications, journals, newspapers/media, reports/experience of work in a reputed university, think-tank, or Research Organization in the area of International Affairs/Public Policy.</li> <li>• Evidence of wide-ranging experience in writing and presentation skills.</li> <li>• Age of the applicant should be between 25-40 years as on last date of submission of the application.</li> </ul>
6.	Desirable Criteria	:	<ul style="list-style-type: none"> <li>• Previous experience in this Ministry.</li> <li>• Knowledge of Foreign Languages.</li> <li>• Subject expertise in IR with as Masters' degree and work experience in reputed academic institutions and international think-tanks/organizations.</li> <li>• Subject expertise in public policy/international public policy including human rights, democracy etc., with a Masters' degree and work experience in reputed international think-tanks/organisations.</li> </ul>
7.	Remuneration & Entitlements	:	<ul style="list-style-type: none"> <li>• The remuneration package will be commensurate with the experience and profile of the selected candidate, subject to a maximum of <b>Rs. 10 lakh per annum</b> and deduction of applicable taxes. The amount of consultancy fee so fixed shall remain unchanged during the term of engagement.</li> <li>• The engagement will be strictly contractual and will not confer any other benefits to the selected candidates.</li> <li>• The consultant shall not be entitled to any benefit like</li> </ul>

			<p>Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the regular employees of the Ministry.</p> <ul style="list-style-type: none"> <li>• No HRA shall be admissible.</li> <li>• The engagement of the Consultant is on full time basis. Normal working hours will be from 0900 to 1730 hrs. Working hours is subject to change from time to time. Saturdays/Sundays will remain closed as weekend off. In exigencies, he/she may be required to work beyond office hours and/or on closed holidays. No extra allowance or remuneration for such work is admissible. He/She shall not accept any other professional appointment, paid or otherwise during the term of engagement with this Ministry.</li> <li>• Paid leave of absence may be allowed at the rate of 1.5 days for each completed month of service. Accumulation of leave beyond a calendar year may not be allowed. Leave cannot be claimed as a matter of right. Leave will not be allowed for more than 10 days at a time. Discretion is reserved to the Head of Division to refuse or revoke leave in the public interest. Leave encashment will not be permissible on unspent leave. Unspent leave will lapse on commencement of notice period. No other leave of any kind shall be admissible to him/her. In case he/she remains absent from duty beyond entitled leave, a proportionate deduction from the consolidated fee as applicable will be made.</li> <li>• In case the Consultant is required to travel as part of his/her duties, the Ministry will take care of his/her travel, accommodation and per-diem costs, as per Ministry's guidelines.</li> <li>• The selected person will be required to enter into a contract with the Ministry in a prescribed format w.e.f. the actual date of engagement as Consultant.</li> </ul>
