3. Candidates are directed to submit only 1 online application even though they are eligible for both the positions with their essential qualifications. As interview will be conducted for the both positions together, the candidature will be considered for both positions; if they are eligible.
4. All the relevant original testimonials (date of birth, degree certificate, experience certificate, etc., if any) will be verified subsequently and a set of attested copies of all the certificates will be required to be submitted by the candidates for verification, before joining, if selected.
