- Qualification:** MBBS with P.G. Degree/Diploma/DNB in the concerned specialty from a recognized University / Institution and should have a valid registration with Delhi Medical Council. Must have not completed 03 years Senior Residency in any recognized institution including regular & adhoc period.
- Pay scale:** Rs.67700 – 208700 of level 11 plus allowances as admissible under the rules.
- Age limit for Junior Residents:** 45 years for Gen. and OBC candidate and age relaxation for SC/ST candidate as per rule.

 - No TA/DA will be paid for appearing in the interview.
 - Hostel accommodation is mandatory for selected candidates subjected to availability.


