Eligibility criteria for SRs:- MD/Post Graduate degree/DNB/Diploma from a recognized university & enrolled with Delhi Medical Council post Graduate Degree/Diploma.

For Pediatrics:- If MD/DNB candidate is not available, then 02 years post MBBS experience with 02 year experience in concerned specialty will also be considered. Candidate must be enrolled with Delhi Medical Council. Candidate must not have completed 03 years SR in any Hospital under state Govt./Govt. of India including Regular or Adhoc.

Age Limit:- Not more than 45 years for SRs (05 Yrs. Relaxation for SC/ST and 03 Yrs. For OBC as on date of interview (vide order no. F No. DHF&W/Q015/57/2016-HR-Medical-Secy (H&FW)/CD No. #112425062/2413-16 dated 04.07.2018.

Emoluments for SR:- Pay matrix of level 11 (Rs. 67700-208700) other usual allowances as admissible under the rules.

Date & time of Interview:- 13.05.24 at 11.00 A.M onward on the mentioned date, Candidates must report on time so that there is no delay In interview.

CONDITION FOR RECRUITMENT:-

- A. All the eligible candidates should report in the office of the undersigned at 9.30 A.M (time for enrollment from 9.30 A.M to 10.30 A.M only) on the day of interview.



- B. For candidate applying for OBC category the certificate must be issued by the competent authority of Govt. of NCT of Delhi. The OBC candidate must be in possession of non-creamy layer certificate for current year.
- C. Person with disabilities shall be given relaxation as per rule
